Therefore, no income tax under section 151 of the Income Tax Ordinance, 2001 read with section 159(1) of the Income Tax Ordinance, 2001 is deductible in the said case.

This exemption certificate is valid upto 30.06.2025 unless cancelled earlier.

The taxpayer is allowed to make supply of goods manufactured by him without tax deduction under clause (a) (b) (c) of sub-section (1) of Section 153 of the Income Tax Ordinance, 2001.
